Check your court date thoroughly! A common mistake is to read the court date incorrectly at the bottom of the citation. The correct format (*left to right*) is: **DAY, DATE, MONTH, YEAR & TIME.**

### WHAT IS REQUIRED OF YOU TO SATISFY A SPRING HILL MUNICIPAL COURT CITATION

You are required to either pay your citation before your court date, or appear before the Municipal Court Judge on the court date shown on the bottom of your citation. Court starts promptly at 9:00 A.M. in the Spring Hill City Hall Courtroom.

#### TRAFFIC SAFETY SCHOOL

If you have a clear driving record for the past 3 years (no moving violations in any state) and you have not completed a traffic safety school class within the past 3 years, then you may be eligible to go to traffic safety school to keep this violation off your driving record. You must appear on your court date so the Judge can determine your eligibility.

#### PLEAD NOT GUILTY

If you wish to plead not guilty, you must either appear on your court date for a hearing to enter a plea of not guilty, or you may waive your right to a hearing and enter a not guilty plea by emailing the court clerk at [jmitchell@springhilltn.org](mailto:jmitchell@springhilltn.org). Once your not guilty plea has been received, your case will be re-set for a trial and the issuing officer will be subpoenaed for court. If you do not receive a confirmation email, call the court office to ensure your plea has been received and to find out the date and time for your trial.

### FAILURE TO APPEAR IS CONTEMPT OF COURT IN SPRING HILL MUNICIPAL COURT

This is a separate offense, which has no relation to your guilt or innocence with respect to the initial violation. Failure to appear on your scheduled court date or pay the citation prior to your court date will result in an additional fine, court cost, litigation tax and an administrative fee in the amount of \$173.75. A collection agency may be used which will result in additional costs and could impact your credit.

#### AMERICANS WITH DISABILITIES ACT

The Americans with Disabilities Act prohibits discrimination against any qualified individual with a disability. The TN Judicial Branch does not permit discrimination against any individual on the basis of physical or mental disability in accessing its judicial programs. In accordance with the Americans with Disabilities Act, if necessary, the Tennessee Judicial branch will provide reasonable modifications in order to access all of its programs, services and activities to qualified individuals with disabilities.

## FINES & FEES FOR SPRING HILL MUNICIPAL COURT ONLY

**If there is more than one violation on your citation, call the court office to get the correct amount due. You only pay court cost & litigation tax/cash bond forfeiture once per citation.**

## FINANCIAL RESPONSIBILITY (NO INSURANCE)

IF YOU HAD INSURANCE COVERAGE WHEN YOU WERE CITED AND DID NOT HAVE YOUR INSURANCE CARD IN THE VEHICLE, YOU MAY PROVIDE PROOF TO THE CLERK. INSURANCE MUST BE IN EFFECT ON THE DAY THE CITATION WAS WRITTEN.

SHOULD INSURANCE NOT BE IN EFFECT WHEN THE CITATION WAS WRITTEN, YOU WILL NEED TO PAY THE CITATION IN THE AMOUNT OF \$138.75. THE STATE WILL BE NOTIFIED AND YOUR LICENSE IS SUBJECT TO SUSPENSION.

## SPRING HILL MUNICIPAL COURT EXPECTATIONS

RESPECTFUL ATTIRE IS REQUIRED INSIDE THE COURTROOM

PERSONS WEARING INAPPROPRIATE CLOTHING TO COURT WILL NOT BE HEARD ON THAT DAY'S DOCKET, BUT WILL BE REQUIRED TO LEAVE COURT

AND APPEAR WHEN THEY CAN APPEAR IN APPROPRIATE ATTIRE. THE DETERMINATION OF WHAT CLOTHING IS INAPPROPRIATE WILL BE MADE BY THE JUDGE.

- NO SHORTS, CAPS OR HATS
- NO HALTER TOPS OR TANK TOPS
- NO EXERCISE ATTIRE
- PANTS MUST BE WORN AT WAIST LEVEL
