



Sale of Age Restricted Products

1.0 PURPOSE

The purpose of this policy is to establish guidelines for the Sale of Age Restricted Products.

2.0 POLICY STATEMENT

It is the policy of Circle K Midwest to prevent the sale of all age-restricted products to minors.

3.0 POLICY

The sale of age restricted products and merchandise is an area of retailing that is receiving increasing scrutiny and subject to increasing liability. It is also an area where employees must exercise the greatest amount of care in complying with the legal requirements of age-restricted sales. To aid associates in these types of situations, this Policy has been designed to help associates understand certain legal obligations and clearly explain state and federal laws and the Company's requirements.

5.0 PROCEDURE

Alcoholic Beverages

In order to purchase any type of alcoholic beverage - beer, wine, malt liquor, cordials, etc. - the purchaser must be at least 21 years of age. There are no exceptions to this rule. An underage person cannot even contribute money to the sale, even if the person handing the money to the employee is 21 years old. The Company's policy does not allow the sale of low alcohol beverages (e.g.: Sharps, O'DOUL'S, etc.) to individuals who are not at least 21 years of age. It is Circle K policy **to ask for and verify identification** from anyone who appears to be under **40** years of age. Some states require an identification to be checked at this age or higher (40 in Indiana and Card All in Tennessee). *See Acceptable Sources of Identification below for a list of acceptable types of identification.* Any associate selling alcohol beverages to an underage person will be terminated.

Alcoholic beverages may not be sold to anyone who appears to be intoxicated. You are also required by law to make an effort to

identify a second party sale. A second party sale is when an adult makes the purchase of an alcoholic beverage for a minor.

Each state imposes a minimum age on the SELLER or HANDLER of alcoholic beverages. In most states, that age is 18.

NOTE: You must check ID prior to scanning the age restricted product.

NOTE: *In Indiana, persons who are at least 19 years old may ring the sale of alcohol in the course of their employment if there is at least one other employee on duty who is 21 years of age or older, and responsible for supervising the minor.*

NOTE: *In Kentucky, however, persons who are 18 or 19 may stock, arrange displays, accept payment for, or bag malt beverages by the package, but only if the activity is done under the supervision of another employee who is at least 20 years of age.*

NOTE: Alcoholic Beverages cannot be sold to anyone during restricted hours or days of the week that alcohol sales are not permitted. It is the responsibility of the store management and associates to know the hours and days of the week that alcohol is not permitted to be sold. (these vary by state and permit)

NOTE: In Indiana a beer dealer shall not be entitled to sell beer in a quantity that exceeds eight hundred sixty-four (864) ounces at any one (1) time.

NOTE: If the customer appears to be under 40 years old, check the customer's ID and scan the ID or type the birth date into the register. If the ID doesn't scan, the birth date must still be checked and typed into the register. Not all states have ID's that can be scanned, but if the ID doesn't read as expected, caution should be taken before completing the sale since this could indicate tampering.

NOTE: It is unlawful to transfer any alcoholic products store to store.

NOTE: In Ohio, drive-through buildings have a "C" class permit and the same laws and regulations apply as the convenience store or gas station permit. However, the seller is not allowed to leave the enclosed part of the building to make the sale.

Note: In Indiana, the Bureau of Motor Vehicles (BMV) no longer issues licenses and ID's at the local BMV and they are mailed from a central location. If the license will expire before the new license should be received, a paper copy of the license that contains a photo is issued and is only valid for 14 days. The paper copy must be presented along with the old license to be valid. The copy cannot be expired, the photos must match and the form cannot be altered or changed in any way to be valid.

Tobacco Products

As of January 1, 2020, all customers who wish to purchase cigarettes including electronic cigarettes, chewing tobacco, vaping products, snuff, rolling papers, and other tobacco or tobacco-like products (e.g.: mint snuff, clove cigarettes) must be at least 21 years of age.

It is the Company's policy **to ask for and verify** identification from anyone who appears to be under 40 years of age. *See Acceptable Sources of Identification below for a list of acceptable types of identification.* Any associate selling tobacco products to an underage person will be separated. Any associate who fails an AVC (BARS) cigarette compliance shop will be subject to disciplinary action for the first offense and separation of employment from Circle K for all second offenses.

NOTE: If the customer appears to be under 40 years old, check the customer's ID and type the birth date into the register.

FEDERAL LAW: It is important to note, effective June 22, 2010 federal law requires that Associates must photo ID all customers age 27 and younger who are purchasing cigarettes, cigars, smokeless tobacco, and e-liquid products. However, as a responsible tobacco retailer Circle K policy requires the verification of a photo ID from all customers purchasing tobacco products who appear to be under the age of 40.

Cannabidiol (CBD)

Purchasers of Cannabidiol (CBD) must be at least 18 years of age (21 in Ohio). It is the Company's policy to ask for and verify the identification from anyone who appears to be under 40 years of age. *See Acceptable Sources of Identification below for a list of acceptable types of ID.*

NOTE: If the customer appears to be under 40 years old, check the customer's ID and scan the ID or type the birth date into the register. If the ID doesn't scan, the birth date must still be checked and typed into the register. Not all states have ID's that can be scanned, but if the ID doesn't read as expected, caution should be taken before completing the sale since this could indicate tampering.

Adult Magazines

Purchasers of adult magazines must be at least 18 years of age. It is the Company's policy to ask for and verify identification from anyone who appears to be under 40 years of age. *See Acceptable Sources of Identification below for a list of acceptable types of identification.*

Lottery Tickets

Purchasers of lottery tickets must be at least 18 years of age. It is the Company's policy to ask for and verify identification from anyone who appears to be under 40 years of age. *See Acceptable Sources of Identification below for a list of acceptable types of identification.*

Fireworks

The Company's policy restricts the sale of fireworks to individuals who are at least 18 years of age. It is the Company's policy to ask for and verify identification from anyone who appears to be under 40 years of age. *See Acceptable Sources of Identification below for a list of acceptable types of identification.*

Vitamins Containing Stimulants

Purchasers of vitamins containing stimulants (e.g.: Mini-Thins, Mini-Slims, Super-Mini, 357 Magnum, etc.) and Energy pills must be at least 18 years of age. It is the Company's policy to ask for and verify identification from anyone who appears to be under 40 years of age. *See Acceptable Sources of Identification below for a list of acceptable types of identification.* If you are in doubt as to whether or not a particular type of vitamin contains a stimulant, check the display case or contact your Store Manager or Market Manager.

Acceptable Sources of Identification

For the purchase of any age-restricted product, the only acceptable forms of identification are:

NOTE: You must check the ID prior to scanning the age restricted product.

1. State issued, valid (non-expired), pictured driver's license – see note regarding Indiana licenses
2. State issued, valid (non-expired), pictured identification card – see note regarding Indiana licenses
3. United States Government issued, pictured passport or passport ID
4. United States Military issued, valid (non-expired), pictured identification card
5. United States Government issued, valid (non-expired) pictured Immigrant identification card

No other form of identification is acceptable, including college ID's, birth certificates, or social security cards.

Note: In Indiana, the Bureau of Motor Vehicles (BMV) no longer issues licenses and ID's at the local BMV and they are mailed from a central location. If the license will expire before the new license should be received, a paper copy of the license that contains a photo is issued and is only valid for 14 days. The paper copy must be presented along with the old license to be valid. The copy cannot be expired, the photos must match

and the form cannot be altered or changed in any way to be valid. No other form of identification is acceptable, including college ID's, birth certificates, or social security cards.

Penalties for Violating Sales Laws

The penalties for violating state or federal laws may be severe. In addition to violating the Company's disciplinary policy, a violation of these laws may include state imposed fines assessed against the employee (regularly totaling \$500 or more), as well as any other liability that may arise. While the Company will be cited by the state every time an employee is convicted of violating the sales laws, the Company will not be held liable for attorneys fees or other costs an employee may be subjected to by the state or other government agencies - rather, the employee must personally pay those costs and fees.

Please don't risk it! If in doubt (if you feel the ID has been altered, if you suspect an adult purchasing for minors, etc.), politely decline the sale. If you have any questions regarding this Policy, please contact your Store Manager, Market Manager, or Human Resources Department.

Store Managers and Market Managers may both lose bonus eligibility under the profit portion of the Bonus Plan for the applicable quarter in which the Corporate Headquarters is notified of the violation. This decision is at the discretion of the Director of Operations.

Reporting Violations and Accountability

Report all violations to your Director of Operations and Loss Prevention Department immediately. Submit a copy of the violation paperwork including FDA Compliance Check Inspections to the person in charge of violations. The employee's name, employee ID, and date of violation should be included with the information submitted.

As a result of the violation, the following actions must be completed.

- The entire store, including the manager, needs to be enrolled in the "MWBU - Age Restricted Sales" eLearning course. Once the violation is reported to the person in charge of violations, they will notify Workday to enroll all team members.
- All team members must complete the course within a week of the violation.
- The employee who violated this policy will be separated and the employee is not eligible for rehire.
- Any associate who fails an AVC (BARS) cigarette compliance shop will be subject to disciplinary action for the first offense and separation of employment from Circle K for all second offenses. Any previous disciplinary action, even if unrelated, could lead to a more severe response with the first failed shop.

- The Store Manager must receive disciplinary action up to and including separation. Any age restricted violations that occur on the Manager’s team after March 2019, even if it was a different location escalates the level of disciplinary action as listed below:
 - 1st Agency violation within 24 months: Written Warning
 - 2nd Agency violation within 24 months: Final Written Warning
 - 3rd Agency violation within 24 months: Separation
- Keep in mind that if the manager has an unrelated disciplinary action within the last year it could escalate the process more quickly. Reach out to your RDO and/or HR as needed to discuss.

General Rules Related to Age Restricted Products

If customers ask questions regarding the Company’s policy on the sale of age-restricted products, an employee’s response should be both polite and brief. Under no circumstance should an employee enter into a debate on the sale of such products.

If an employee learns of a change in the law in the city or state where their store operates which would serve as a ban on any such product, the Market Manager must be contacted. An employee should not ban the sale of an age-restricted product from being sold in the store without first getting the approval from the Director of Operations.

I searched the Spring Hill Police Department's database and online criminal databases for the following individuals: Melissa A. Duncan and Leah D. Phillips. No criminal findings were revealed.

I searched the Department of Justice's Sex Offender Registry for Melissa A. Duncan and Leah D. Phillips. No findings were revealed. California's SOR database was down at the time of search.
