Dear Valued Building and Development Partners,

The City of Spring Hill is providing the following notice in accordance with Title 5, Chapter 5, Section 517 of the Municipal Code. This section of the code provides for an automatic annual adjustment for Roadway Impact Fees based on the Engineering News Record Construction Cost index. The fees will be increased by 7.14% effective January 1, 2024. The new fee schedule is included below for your convenience.
