

RESOLUTION 24-55

TO ACCEPT CONVEYANCE OF JIM WARRE ROAD AND CRAFTON ROAD RIGHT-OF-WAYS FROM MAURY COUNTY, TN

WHEREAS, the City of Spring Hill requested Maury County to convey Jim Warren Road and Crafton Road within Maury County limits to Spring Hill since a large portion of these roads run through the city limits of Spring Hill; and

WHEREAS, Maury County Highway Department expressed its agreement in regards to the conveyance of these two roads to the City; and

WHEREAS, Maury County has executed a quit claim deed on February 20, 2024, conveying the County's right-of-ways on these two roads to the City; and

WHEREAS, once the City accepts these roads, the roads will be removed from the County road list and added to the City's road list.

NOW THEREFORE, BE IT RESOLVED, that the City of Spring Hill, Board of Mayor and Aldermen accepts the quit claim deed conveying the County's right-of-ways on Jim Warren Road and Crafton Road within Maury County limits to the City of Spring Hill.





**RESOLUTION APPROVING CONVEYANCE OF JIM WARREN ROAD AND
CRAFTON ROAD RIGHT OF WAYS TO THE
CITY OF SPRING HILL**

WHEREAS, the City of Spring Hill, Tennessee has requested Maury County to convey Jim Warren Road and Crafton Road since a large portion of these roads run through the city limits of Spring Hill; and

WHEREAS, the Maury County Highway Department has expressed its agreement with the conveyance of these two roads to the City of Spring Hill; and

WHEREAS, the attached quit claim deed conveying the County's right of way in these two roads to Spring Hill, Tennessee is approved; and

WHEREAS, once Spring Hill accepts these roads the road list will be amended to remove the roads from the County Road list.

NOW, THEREFORE, BE IT RESOLVED by the Maury County Commission that the attached quit claim deed conveying the County's right of way in Jim Warren Road and Crafton Road to the City of Spring Hill, Tennessee is approved, and the County Mayor is authorized to execute the deed.

BE IT FURHTER RESOLVED by the Maury County Commission that once Spring Hill, Tennessee accepts these roads, the Maury County Road list will be amended and these roads will be removed.
