A RESOLUTION TO APPROVE THE PURCHASE OF BALLISTIC VESTS FOR FIRE DEPARTMENT APPARATUS

WHEREAS, the City of Spring Hill operates a career fire department that responds to all hazards within the city; and

WHEREAS; the Fire Department is regularly one of the initial responders to acts of violence that may include domestic assaults, active shooter incidents, or other civil unrest; and

WHEREAS; fire department personnel are required to wear and utilize personal protective equipment (PPE) during these types of incidents; and

WHEREAS, it is the responsibility of the Fire Department to provide such PPE; and


WHEREAS, the Fire Department developed a set of specifications and protection parameters for the ballistic protection and has located a vendor that is a member of a participating cooperative purchasing organization.

NOW, THEREFORE BE IT RESOLVED, the City of Spring Hill Board of Mayor and Aldermen authorize the Fire Department to purchase (25) ballistic vests and (50) ID Patches from North American Rescue using Buy-Board Contract 698-23 in the total amount of \$27,988.50.



PURPOSE:

The purpose of this resolution is to approve the purchase of ballistic vests from North American Rescue through Buy Board Group Purchasing Contract 698-23.

BACKGROUND:

Fire Department will be replacing the ballistic vests that are currently out of date with (25) new vests and (50) ID Panels that will be placed on apparatus to be used on emergency scenes such as active shooter incidents, civil unrest, or medical/trauma calls resulting from police incidents secondary to domestic disputes with weapon involvement.

FINANCIAL IMPACT:

Funding for this would be from the Fire Department FY25 Budget 110-42220-53265.

Staff recommends approval of Resolution 24-XXX to approve the purchase of the specified (25) ballistic vests and (50) ID Panels.
