

ORDINANCE 11-06

AN ORDINANCE TO ANNEX THE PROPERTY OF TENNESSEE CHILDREN'S HOME, LOCATED ON THE CORNER OF DR. ROBERTSON ROAD AND BEEHCROFT ROAD, TO INCLUDE 2,150 FEET OF DR. ROBERTSON ROAD RIGHT OF WAY BEGINNING AT BEEHCROFT ROAD, CONTAINING 84.9 ACRES MORE OR LESS, MAURY COUNTY TAX MAP 024 PARCEL 014

WHEREAS, it appears the Board of Mayor and Aldermen of the City of Spring Hill that the prosperity of the City of Spring Hill and the affected territory will be materially disadvantaged unless the territory is annexed to the corporate limits of the City of Spring Hill; and

WHEREAS, the property owner listed in this Ordinance has requested annexation in order to insure the value and availability of this property for future uses; and

WHEREAS, the natural growth area of the City of Spring Hill will include these parcels;

BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF SPRING HILL, TENNESSEE that:

Pursuant to Tennessee Code Annotated Section 6-51-101 et seq., the property vested in property owners, Tennessee Children's Home, as shown on Maury County Tax Map 024 Parcel 014, located on the corner of Dr. Robertson Road and Beehcroft Road, to include two thousand, one hundred fifty (2,150) feet of Dr. Robertson Road right of way beginning at Beehcroft Road, containing approximately 84.9 acres, more or less, is hereby annexed to the corporate limits of the City of Spring Hill, Tennessee, and made a part thereof.


Annexation of said territory adjoining the City's existing boundaries is necessary for the welfare of the affected territory as well as the City as a whole.

A map showing the said territory is available for inspection at the City Hall in Spring Hill, Tennessee.


This Ordinance was passed after the adoption of a plan of services for the property in conformity with, and as provided by, Tennessee Code Annotated, Section 6-51-102.

Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 18th day of April, 2011.


