

ORDINANCE 10-25

AN ORDINANCE TO AMEND SPRING HILL MUNICIPAL CODE TO AMEND TITLE 2, "BOARDS AND COMMISSIONS", CHAPTER 4, SECTION 2-402 (3) A, AS IT PERTAINS TO HISTORIC COMMISSION APPOINTEES

WHEREAS, the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee, created a Historic Commission;

WHEREAS, the Board of Mayor and Aldermen of the City of Spring Hill wishes to allow representatives of historically significant properties to serve on the Spring Hill Historic Commission; and

WHEREAS, Section 2-402 (3) a currently reads,

(3) "Three at-large members of the Spring Hill Historic Commission shall be appointed by the Mayor pursuant to the following provisions:

- a. Each of the appointees shall own property in the City or be a resident of the City. Terms of the members, after expiration of the initial members' terms, shall be three years. The initial term of the first appointment shall be one (1) year. The initial term of the second appointment shall be two (2) years. The third initial appointment shall serve a three (3) year term. After the service of the initial term each member will be appointed to serve a three (3) year term."*

BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF SPRING HILL, TENNESSEE, THAT; TITLE 2, "BOARDS AND COMMISSIONS" SECTION 2-402 (3) A, IS HEREBY AMENDED TO READ:

(3) "Three at-large members of the Spring Hill Historic Commission shall be appointed by the Mayor pursuant to the following provisions:

- a. Each of the appointees shall own property in the City or be a resident of the City, or represent a historically significant property within the City limits. Terms of the members, after expiration of the initial members' terms, shall be three years. The initial term of the first appointment shall be one (1) year. The initial term of the second appointment shall be two (2) years. The third initial appointment shall serve a three (3) year term. After the service of the initial term each member will be appointed to serve a three (3) year term."*

BE IT FURTHER ENACTED, that all Ordinances or parts of Ordinances in conflict herewith, are and the same hereby are repealed or modified as the case may be.

BE IT FURTHER ENACTED, that this Ordinance shall take effect from and after its adoption, the public welfare requiring it.


