

**ORDINANCE NO. 01-49**

**AN ORDINANCE TO ANNEX CERTAIN PROPERTY OF STEVEN WILLEY, SUCH PROPERTY LOCATED AT 4471 TOM LUNN ROAD, AND AS SHOWN ON MAURY COUNTY TAX MAP 43, PARCELS 9.04, 42.52 ACRES, 9.11, 10.42 ACRES, CONSISTING OF A TOTAL ACREAGE OF 52.94, MORE OR LESS**

**WHEREAS**, it appears to the Board of Mayor and Aldermen of the City of Spring Hill that the prosperity of the City of Spring Hill and the affected territory will be materially retarded unless the territory is annexed to the corporate limits of the City of Spring Hill, and;

**WHEREAS**, the property owner listed in this Ordinance 01-49 has requested annexation in order to insure the value and availability of his property for future uses, and

**WHEREAS**, the natural growth area of the City of Spring Hill will include these parcels

**BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF SPRING HILL, TENNESSEE** that:

Pursuant to Tennessee Code Annotated Section 6-51-101 et seq., the property vested in Steven Willey, being a part of Maury County Tax Map 43, Parcel 9.04, and 9.11, and totaling 52.94 acres, more or less, is hereby annexed to the corporate limits of the City of Spring Hill and made a part thereof.

Annexation of said territory adjoining the City's existing boundaries is necessary for the welfare of the affected territory as well as the City as a whole.


A map showing the said territory is available for inspection at City Hall in Spring Hill, Tennessee.

This Ordinance was passed after the adoption of a plan of services for the property in conformity with and as provided by Tennessee Code Annotated, Section 6-51-102.

This Ordinance shall become effective thirty (30) days after its final passage.

This Ordinance was passed on second reading upon the recommendation of the Spring Hill Planning Commission made on November 12, 2001 (corrected plat), and after a public hearing before the Board of Mayor and Aldermen on January 21, 2002, and after due publication in The Journal on January 15, 2002.


