

**ORDINANCE NO. 96-29**

**AN ORDINANCE TO CORRECT  
THE SPRING HILL MUNICIPAL CODE BY  
DELETING REFERENCES TO ORDINANCE NO. 93-23  
WHICH WAS NEVER ENACTED**

**Whereas**, the Municipal Technical Advisory Service of the Institute for Public Service of the University of Tennessee, in preparing the new Spring Hill Municipal Code included under Title 20 - Miscellaneous, Chapter 1 - Impact Fees and Taxes on Developments, Sections 20-101, 20-102, and 20-103, all of which are based upon Ordinance No. 93-23, which ordinance never passed second reading and was thus never enacted by the Board of Mayor and Aldermen of the Town of Spring Hill, Tennessee.

**BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE** that the Spring Hill Municipal Code is amended as follows:

1. Sections 20-101, 20-102, and 20-103 of the Spring Hill Municipal Code are deleted in their entirety.
2. Title 20, Chapter 1 is designated "(RESERVED)", as shown on the attached revised page 20-1.
3. The Table of Contents is amended as shown on the attached revised Table of Contents page.
4. Footnote 1 on page C-37 is changed to read: "Ord. #94-2 established certain impact fees and taxes on developments and developers of projects within the town. These fees and taxes are set out in title 5, chapters 5 and 6 in the municipal code."
5. Footnote 1 on page 18-9 is deleted.
