

**AN ORDINANCE TO AMEND
THE SPRING HILL MUNICIPAL CODE TO
INCORPORATE THEREIN THE SEWER CONNECTION CHARGE**

Whereas, the Municipal Technical Advisory Service of the Institute for Public Service of the University of Tennessee, in preparing the new Spring Hill Municipal Code, did not include the Sewer Connection Charge previously established by the Board of Mayor and Aldermen for inclusion in the Municipal Code.

BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE that the Spring Hill Municipal Code is amended by the inclusion of new Section 18-311, as follows. When feasible, this new section shall be renumbered as Section 18-109 (following 18-108. Water connection charge), and subsequent sections renumbered accordingly. The new section to be included is as follows:

18-311. Sewer connection charge.

(1) The following charges are hereby imposed for each connection made to the sanitary sewer system of the Town of Spring Hill, Tennessee:

- (A) Single family dwelling units: \$1,000.00.
- (B) Duplexes: \$1,000.00 for each family dwelling unit.
- (C) Apartments: \$500.00 for each family dwelling unit and office.
- (D) All other buildings:
 - a. \$1,000.00 for a 4" tap.
 - b. \$1,200.00 for a 6" tap.
 - c. \$1,500.00 for an 8" tap.

(2) The fees imposed hereby shall be collected before the issuance of any permit for connection to the sewer system of the Town of Spring Hill. These fees shall be in addition to any and all other fees and charges imposed by other ordinances or resolutions of the Town of Spring Hill.

(3) All material and equipment for construction or maintenance of sanitary sewer lines and connections must meet Town of Spring Hill specifications and approval. All work must be inspected by an authorized representative of the Town.

(4) All funds collected through these connection charges shall be placed in an account to be known as the Wastewater Rehabilitation and Extension Account. All funds in said account shall be

used solely for extending sewer lines, rehabilitating existing lines, replacing existing lines with larger capacity lines, or adding to the capacity of the wastewater treatment facilities of the Town of Spring Hill.
