

**ORDINANCE NO. 95-6**

**AN ORDINANCE TO ANNEX THE CAMERON  
PROPERTY ON THE EAST SIDE OF BUCKNER LANE  
(WILLIAMSON COUNTY TAX MAP 154, PARCEL 62.03),  
CONTAINING APPROXIMATELY 112 ACRES TO THE  
CORPORATE LIMITS OF THE TOWN OF SPRING HILL**

**Whereas**, the owner of the property hereinafter described in Williamson County, Tennessee, has petitioned the Board of Mayor and Aldermen of the Town of Spring Hill that it be annexed to the Spring Hill corporate limits; and

**Whereas**, it appears to the Board of Mayor and Aldermen of the Town of Spring Hill that the prosperity of the Town of Spring Hill and the territory hereinafter described which is proposed to be annexed by this ordinance will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered unless the territory is annexed to the corporate limits of the Town of Spring Hill.

**BE IT THEREFORE ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE** that, pursuant to Part 1 of Chapter 51 of Title 6 of Tennessee Code Annotated, the property vested in Tim L. Cameron, Trustee of the Cameron Children Trust, bounded on the Thompson Station to Burwood Road on the north, and on the west by Buckner Lane, Williamson County Tax Map 154, Parcel 62.03, containing approximately 112 acres is hereby annexed to the corporate limits of the Town of Spring Hill and made a part thereof.

The legal description of the property is as follows:

Said tract lies wholly within the Eleventh Civil District, Williamson County, Tennessee, and bounded in general by Thompson Station to Burwood Road on the north, formerly Pratt farm on the east, Reed on the south and Buckner Lane on the west.

Beginning at the point of interception of the center lines of Buckner Lane and the Thompson Station to Bethesda Road, thence with the following two calls along the center line of the Thompson Station to Bethesda Road, South 87 degrees 08 minutes 39 second East 2300.0 feet and South 82 degrees 33 minutes 02 second East 2062.5 feet to the northwest corner of a tract formerly owned by Pratt, thence South 2 degrees 15 minutes west leaving said center line and with his west fence line, 1123.3 feet to the northeast corner of Reed, thence with his north fence line with the following four calls: North 85 degrees 04 minutes West 965.0 feet, North 82 degrees 52 minutes 36 seconds West 2578.0 feet, North 44 degrees 27 minutes West 12.0 feet and North 82 degrees 52 minutes 30 seconds West 880.9 feet to the center of Buckner Lane, thence with said center line, North 6 degrees 01 minutes 12 seconds East 983.4 feet to the point of beginning and containing 112.02 acres, more or less.

Being part of the same property conveyed to Tim L. Cameron, Trustee of the Cameron Children Trust, by deed from Dorothy Sullivan Cameron McDonnell of record in Book 472, Page 988, Register's Office of Williamson County, Tennessee.

The area set forth above is described by the map and parcel designation set forth in the records of the Office of the William County Assessor of Properties. A map showing this area is available for inspection at the City Hall in Spring Hill, Tennessee.




