

ORDINANCE NO. 88-14

AN ORDINANCE TO ANNEX THE PROPERTY OF HARRIET MCCORD MARTIN AND ALFRED MARTIN (TAX MAP NO. 43, Parcel 14,), TO THE CORPORATE LIMITS OF THE TOWN OF SPRING HILL.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL:

WHEREAS, Harriet McCord Martin and Alfred Martin, the owners of property designated as Tax Map No. 43, Parcel 14, on the West side of Port Royal Road, have petitioned the Board of Mayor and Aldermen of the Town of Spring Hill that this property be annexed to its corporate limits; and

WHEREAS, it appears to the Board of Mayor and Aldermen of the Town of Spring Hill, that the prosperity of the Town of Spring Hill and the property owned by Mr. and Mrs. Martin will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered unless this property is annexed to the corporate limits of the Town of Spring Hill;

NOW, THEREFORE, BE IT ORDAINED by the Board of Mayor and Aldermen of the Town of Spring Hill, that the property of Harriet McCord Martin and Alfred Martin on the West side of Port Royal Road, the same being Tax Map No. 43, Parcel 14, be annexed to and become a part of the corporate limits of the Town of Spring Hill.


BE IT FURTHER ORDAINED that the Board of Mayor and Aldermen deems the annexation of this property to be necessary for the welfare of the residents and property owners of the area annexed as well as the municipality as a whole.

This Ordinance was passed on third reading after a public hearing was held on December 19, 1988, upon the question of this annexation after notice thereof was published in the Columbia Daily Herald on November 28, 1988.

This Ordinance was further passed after the adoption of the Plan of Services for the area proposed to be annexed in conformity with and as provided by Section 6-51-102 of Tennessee Code Annotated.

BE IT FURTHER ORDAINED that this Ordinance shall become operative thirty (30) days after the final passage thereof.


