

ORDINANCE NO. 88-15

AN ORDINANCE TO ANNEX THE PROPERTIES OF JAMES ED RICE, SR. AND OTHERS (TAX MAP NO. 49, Parcel 1 AND TAX MAP NO. 50, PARCEL 11), TO THE CORPORATE LIMITS OF THE TOWN OF SPRING HILL.

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL:

WHEREAS, James Ed Rice, Sr. and the other owners of properties designated as Tax Map No. 49, Parcel 1 and Tax Map 50, Parcel 11, on the East side of Port Royal Road and North of the Kedron Pike, have petitioned the Board of Mayor and Aldermen of the Town of Spring Hill that this property be annexed to its corporate limits; and

WHEREAS, it appears to the Board of Mayor and Aldermen of the Town of Spring Hill, that the prosperity of the Town of Spring Hill and these properties owned by James Ed Rice, Sr. and the other owners will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered unless this property is annexed to the corporate limits of the Town of Spring Hill;

NOW, THEREFORE, BE IT ORDAINED by the Board of Mayor and Aldermen of the Town of Spring Hill, that the properties of James Ed Rice, Sr., and the other owners, on the East side of Port Royal Road and North of the Kedron Pike, the same being Tax Map No. 49, Parcel 1 and Tax Map No. 50, Parcel 11, be annexed to and become a part of the corporate limits of the Town of Spring Hill.

BE IT FURTHER ORDAINED that the Board of Mayor and Aldermen deems the annexation of this property to be necessary


for the welfare of the residents and property owners of the area annexed as well as the municipality as a whole.

This Ordinance was passed on third reading after a public hearing was held on December 19, 1988, upon the question of this annexation after notice thereof was published in the Columbia Daily Herald.



BE IT FURTHER ORDAINED that this Ordinance shall become operative immediately upon its passage.


