

ORDINANCE 86-41

AN ORDINANCE CHANGING THE WATER AND SEWER SERVICE CHARGE RATES

BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL, TENNESSEE:

Section 1. That the charges for water and sewer service furnished by the Town of Spring Hill are hereby changed to the following schedules:

In accordance with Section 13-9 of the Spring Hill Water and Sewer Ordinance, the Mayor and Board of Aldermen hereby establish the following Schedule of Rates and Charges for Water and Sewer Service.

- I. Availability Charges (Section 13-38(b)): This charge is composed of two elements, one based on the demand on the system and the other on the size of the property.
1. The administrator shall determine the proposed use of the property and calculate the demand on the system by using the table attached to this schedule as Appendix A (which sets forth the average demand generated by development of various types). If anticipated demand cannot be determined from Appendix A, then the administrator shall make the determination based upon the best information available. To determine the first component of the availability fee, the total anticipated demand, expressed in gallons per day, shall be multiplied by ~~\$2.00 per g.p.d. for water and~~ ~~\$3.50 per g.p.d. for sewer.~~
  2. The second component of the availability charge shall be determined by multiplying the size of the lot to be served (expressed in acres or fractions thereof, rounded to two decimal points) by \$300 per acre, except that in no case shall the acreage component of the availability charge for service to a single dwelling unit exceed \$300.
