

CONSENT

The undersigned hereby confirms that the Transferor is the party named in the Franchise and that the Franchise is in full force and effect.

AN ORDINANCE CONSENTING TO
THE ASSIGNMENT BY FNI
COMMUNICATIONS COMPANY OF A
CABLE TELEVISION FRANCHISE
GRANTED BY ORDINANCE NO. 80-5

TO BE EFFECTIVE APRIL 18, 1984

BE IT ORDAINED BY THE BOARD OF MAYOR AND
ALDERMEN OF THE TOWN OF SPRING HILL:

WHEREAS, by Ordinance No. 80-5 (passed and approved by the Board of Mayor and Aldermen of the Town of Spring Hill, Tennessee, on November 17, 1980), the Town of Spring Hill, Tennessee granted to FNI Communications Company, a Tennessee corporation ("FNI"), the non-exclusive right to erect, maintain, operate and utilize facilities for the operation of a community antenna television system and additions thereto, on the terms and conditions set forth in said Ordinance No. 80-5 (the "Franchise"); and

WHEREAS, FNI has entered into an Asset Purchase Agreement dated as of February 27, 1984 (the "Agreement") with FNI Cable Associates, a Tennessee limited partnership, which provides, among other things, for the assignment of the Franchise and all rights, privileges and obligations thereunder on the terms provided in the Agreement;

NOW, THEREFORE, be it ordained by the Board of Mayor and Aldermen of the Town of Spring Hill:

(a) That the Town of Spring Hill hereby consents to the transfer of the Franchise by FNI to FNI Cable Associates, a Tennessee limited partnership controlled by Monroe M. Rifkin and Naragansett Capital Corporation (the "Principals") and to the subsequent transfer of the Franchise by said limited partnership to FNI Communications Associates, a limited partnership also controlled by the Principals;

(b) That the Town of Spring Hill hereby confirms that FNI is the grantee of the Franchise and that the Franchise is in full force and effect; and

(c) That the appropriate officials of the Town of Spring Hill be, and they hereby are, authorized to execute and deliver on behalf of the Town of Spring Hill a consent to the effect set forth in clauses (a) and (b) above, effective April 18, 1984.

(d) That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
