

RESOLUTION NO. 86-5

R E S O L U T I O N

WHEREAS, by a Resolution adopted on the 17th day of February, 1986, a Plan of Services was proposed for areas under consideration for annexation to the Town of Spring Hill; and

WHEREAS, by this Resolution the proposed Plan of Services was submitted to the Spring Hill Regional Planning Commission for study and written report; and

WHEREAS, at a meeting of the Planning Commission held on February 20, 1986, a study was conducted on the Plan of Services and it was unanimously approved by this Board which submitted its written report to the Board of Mayor and Aldermen; and

WHEREAS, pursuant to a Resolution adopted by the Board of Mayor and Aldermen at a called meeting held on February 20, 1986, the Recorder and City Attorney were instructed to give notice of a public hearing to be held on the proposed Plan of Services and this notice was accordingly published in the Columbia Daily Herald on February 21, 1986, giving notice of the public hearing to be held at 6:00 o'clock P.M. on Monday, March 3, 1986, at the Spring Hill City Hall; and

WHEREAS, pursuant to this notice a public hearing was held before the Board of Mayor and Aldermen on March 3, 1986; and

WHEREAS, the Board of Mayor and Aldermen has considered matters raised at the public hearing and has determined the proposed Plan of Services should be approved;

NOW, THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the Town of Spring Hill that the proposed Plan of Services submitted to the Planning Commission on February 17, 1986, be and the same is hereby adopted.

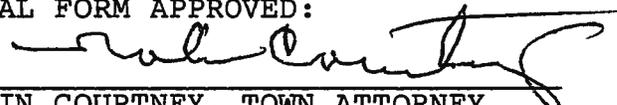

To execute said applications for CDBG funds and enter into all necessary agreements and assurances to consummate the application; and

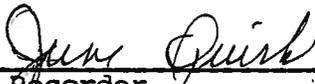
BE IT FURTHER RESOLVED, that the Town of Spring Hill, Tennessee, is in support of the application.
