WHEREAS, the Spring Hill Regional Planning area extends to a point 1,000 feet west of Carter's Creek Pike, northwardly to the Maury-Williamson County line; and

WHEREAS, certain individuals owning properties abutting the Carter's Creek Pike north of Beechcroft Road have requested the Spring Regional Planning Commission to relinquish its planning authority from Beechcroft Road northwardly to the county line so as to relinquish the area lying west of the Carter's Creek Pike and 300 feet east of the Carter's Creek Pike; and

WHEREAS, this Board and the Spring Hill Regional Planning Commission have recommended that this request be granted;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE TOWN OF SPRING HILL that the Town of Spring Hill surrender that portion of its planning region that lies within an area the east boundary line of which is a line 300 feet east of and parallel to the Carters Creek Pike from Beechcroft Road northwardly to the Maury-Williamson County line.




