**WHEREAS**, the Spring Hill Municipal Planning Commission holds regular monthly meetings also established by this 2011 calendar; and



**WHEREAS**, the Chairman of the Planning Commission or the Mayor has the authority to call special meetings or public hearings in addition to those regularly scheduled; and


**WHEREAS**, the attached calendar of 2011 meetings shall be advertised as a notice in the local newspapers and shall be posted on the City of Spring Hill website; and
