WHEREAS, to better serve the citizens of Spring Hill, the City accepted proposals for road improvements on November 5, 2010; and


WHEREAS, the City of Spring Hill approved road improvement projects in the 2010-2011 Capital Improvement Plan; and

WHEREAS, the City of Spring Hill advertised and received proposals on November 5, 2010 for the paving of the following roads: Depot Street, Grey Fox Drive, Timberwood Court, Quail Court, Dove Court, Hunter's Point, Hunter's Point Loop, Prescott Way, and Kedron Parkway; and


NOW, THEREFORE BE IT RESOLVED, that the City of Spring Hill authorizes awarding the above referenced Multi-Road paving projects, excluding Hunter's Pointe Lane and Hunter's Pointe Loop, to Tennessee Valley Paving Company in an amount not to exceed \$185,000.00, as recommended by staff and Spring Hill Budget and Finance Advisory Committee on November 8, 2010.

BE IT FURTHER RESOLVED that funding for this paving project to be drawn from the General Funds, Streets Department.




