**A RESOLUTION TO APPROVE LEASE-PURCHASE FINANCING
OF EQUIPMENT FOR POLICE VEHICLES**


WHEREAS, the City of Spring Hill, Board of Mayor and Aldermen approved the purchase of new police vehicles on August 15, 2011 in Resolutions 11-79, 11-80, and 11-81; and

WHEREAS, the City of Spring Hill advertised Request for Proposals Lease Purchase of vehicle equipment and accepted proposals on December 5, 2011; and

WHEREAS, City Staff received and reviewed proposals; and

NOW, THEREFORE BE IT RESOLVED, that the City of Spring Hill approves the Lease-Purchase financing of new Police vehicles equipment, as recommended by staff, from US Bancorp Equipment Finance, Greencove, NY., at an interest rate of 2.02%, for a term of 3 years, with first payment due on acceptance. Recommended by the Budget and Finance Advisory Committee on December 12, 2011.

Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 19th day of December 2011.






