**WHEREAS**, to better serve the citizens of Spring Hill, the City accepted proposals for various road improvements on December 29, 2011; and


**WHEREAS**, the City of Spring Hill previously activated the Performance Bond conditions to secure the funding for roadways in Hampton Springs Subdivision; and

**WHEREAS**, the City of Spring Hill desires to install street lights in Hampton Springs Subdivision; and



**BE IT FURTHER RESOLVED** that funding for this project to be drawn from proceeds from the Hampton Springs Bond.


