WHEREAS, the Spring Hill Fire Department is in need of a new SUV; and


WHEREAS, the City of Spring Hill included the purchase of one SUV in the budget for fiscal year 2013-2014; and

WHEREAS, City Staff has made a recommendation to the Budget Finance Advisory Committee; and



OVERVIEW: The Spring Hill Fire Department was allocated money in the budget to replace Fire Chief Car #1.

HIGHLIGHTS:

- This purchase is to replace older model vehicles with high mileage.

PROJECT/CONTRACT UPDATES:

- The statewide contract price for vehicles has historically been the lower or lowest price compared to the bid pricing we receive through RFP. By purchasing off of the statewide contract, we will save the cost of advertising and due to the time constraints of submitting a RFP, we will be able to take possession of the vehicles sooner than we would by bidding out the vehicles.

Total cost of vehicles \$32,556.00. This is for vehicle purchase only. Equipment to be purchased separately from a different vendor to include all installation at a cost of \$6,012.04 making a grand total price of \$38,568.04.

ACTION ITEMS:

- Request that this fire staff vehicle be purchased off of the State Wide Contract through GM of Murfreesboro, who has the contract with the State for these vehicles.
