**A RESOLUTION AUTHORIZING A SPECIAL CENSUS TO DETERMINE  
THE CURRENT POPULATION OF THE CITY OF SPRING HILL**

**WHEREAS**, Spring Hill is continuing to experience phenomenal residential growth; and

**WHEREAS**, the State Revenue Department distributes shared revenue on a per-capita basis so an increase in certified population numbers will mean a significant increase in revenue for the City; and

**WHEREAS**, the City's engineering firm, Dempsey, Dilling and Associates conducted three special censuses for the City between 2000 and 2010 and has the professional experience required for this endeavor;

**NOW, THEREFORE BE IT RESOLVED** by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee, that a census to determine the current population of Spring Hill is hereby authorized to be conducted by Dempsey, Dilling and Associates at an approximate total cost of \$100,000.00.

**BE IT FURTHER RESOLVED** that the census begin as soon as practical after the adoption of this Resolution.
