WHEREAS, the Water Treatment Plant and the Sewer Collection Department are in need of Sport Utility Vehicles; and



WHEREAS, city staff had made a recommendation to the Budget and Finance Advisory Committee; and



Passed and adopted by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee on the 21st day of July, 2014.




