

**RESOLUTION 14-144**


**A RESOLUTION REQUESTING THE MAURY COUNTY ELECTION COMMISSION TO CONDUCT AN ELECTION WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF SPRING HILL, TENNESSEE, ON THURSDAY, APRIL 9, 2015, TO ELECT ONE (1) ALDERMAN FROM EACH OF THE FOUR (4) WARDS, PURSUANT TO THE ELECTION LAWS OF THE STATE OF TENNESSEE**

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Mayor and Aldermen of the City of Spring Hill, Tennessee, that:

The Maury County Election Commission is requested and authorized to conduct the regular municipal election for the City of Spring Hill, Tennessee, on Thursday, April 9, 2015, for the purpose of electing one (1) Alderman from each of the four (4) wards, all to be voted on at-large by the registered voters of the city, each Alderman to serve a term of four (4) years. The Maury County Election Commission is requested to publish notice of the election in both Maury and Williamson Counties.

The Mayor is hereby authorized to request the Maury County Election Commission to hold a period of early voting, and the aforesaid regular election on April 9, 2015, at the Winchester Community Center on Maury Hill Street, Spring Hill, TN, the cost of which shall be borne by the City of Spring Hill, Tennessee.



**PURPOSE:**

It is time to begin preparing for the 2015 City Election.

**BACKGROUND:**

Election requirements are established in the Spring Hill Municipal Code.

**FINANCIAL IMPACT:**

The City of Spring Hill has budgeted \$19,000.00 for the 2015 City Election. Expenditures for the 2013 Election were approximately \$17,999.00; Expenditures for the 2011 Election were approximately \$15,000.00.

**STAFF RECOMMENDATION:**

Approval

**ACTION REQUIRED (INCLUDE DEADLINE /PRIORITY):**

The City of Spring Hill is required by law to request that the Maury County Election Commission hold an Election by December 25, 2014.

**INFORMATION ON CERTIFYING THE ELECTION AND POLLING LOCATIONS:**

The Commission will decide when to certify the election. By law, they have until the 3<sup>rd</sup> Monday after the election to certify. They typically certify on the second Monday. It is almost impossible to certify the first Monday after the election because of possible provisional ballots. If someone cast a provisional ballot because of lack of ID, they have 2 days following the election to bring their ID to the office and if they do, we will count their ballot. With Spring Hill's election being on a Thursday, voters have until Monday at 4:00 pm to bring their ID into the office.

I think my board would be willing to work with your board on certifying as early as possible. However, I don't think we could do it before Tuesday. Let me know when your board wants to swear the new members in. We will try to work with that if possible.

Polling locations, Early Voting for all voters of Spring Hill, both Maury and Williamson, will be held at the Community Building. Early voting will begin March 20 and end April 4. Keep in mind Good Friday falls on April 3. Polling locations for election day will be the Longview Rec center for Williamson voters and Spring Hill Community Center and Spring Hill High for Maury voters.
