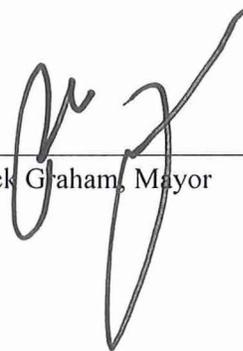
**A RESOLUTION TO AUTHORIZE THE PURCHASE AND INSTALLATION OF

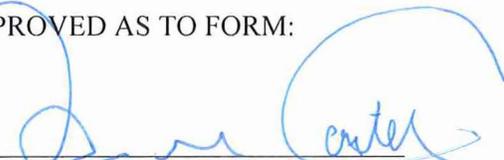
