A RESOLUTION TO APPROVE THE PURCHASE OF TELEVISIONS FOR THE NEW POLICE DEPARTMENT HEADQUARTERS

WHEREAS, the City of Spring Hill is in the process of completing the construction of the new Police Headquarters; and

WHEREAS, the Department will need televisions in the Police Headquarters for training and other purposes; and

WHEREAS, the Police Department request authorization to purchase various sizes of televisions from Pro Logic, GSA contract 47QSMS24D003D, per the quote attached hereto as Exhibit A; and

WHEREAS, the televisions will be expensed from the 18-75 fund using FY25 budgeted funds.

NOW, THEREFORE BE IT RESOLVED, that the City of Spring Hill Board of Mayor and Alderman approve the Police Department to purchase televisions for the new Police Headquarters from Pro Logic, GSA contract, 47QSMS24D003D, for \$ 62,907.30.


