WHEREAS, pursuant to Tennessee Code Annotated § 13-4-201 and 13-4-202, it is the function and duty of the City of Spring Hill Planning Commission to make and adopt a general plan for the physical development of the municipality; and

WHEREAS, the City of Spring Hill Board of Mayor and Aldermen has previously adopted the Major Thoroughfare Plan in May, 2015 for the City of Spring Hill;

WHEREAS, the City of Spring Hill Planning Commission has approved resolution 17-19 to amend the 2040 Major Thoroughfare Plan for the City of Spring Hill by changing the classification of Tom Lunn Road from a local street to a collector street, without conditions, on March 13th, 2017;



WHEREAS, that this resolution shall become effective immediately upon its adoption.



SUBJECT: Major Thoroughfare Plan Amendments

The following two amendments were initiated by the Planning Commission in response to in response to development trends within the community. Both have been processed through the Planning Commission for approval. The amendments are bring brought to the Board of Mayor and Aldermen for consideration and approval.

Tom Lunn Road: This amendment is being processed by the Planning Department to amend the classification of Tom Lunn Road, in the Major Thoroughfare Plan, from a local street to a collector street.

Description and History: Given the amount of development interest on Tom Lunn Road the Planning Commission requested that staff prepare a resolution to amend the Major Thoroughfare Plan, originally adopted by the Board of Mayor and Aldermen in 2015. The City has provided a 30-day public notice in the newspaper. The Planning Commission approved Resolution 17-19 to change the classification of Tom Lunn Road on March 13th, 2017:

1. **Resolution 17-19:** Submitted by the Planning Department to amend the classification of Tom Lunn Road in the Major Thoroughfare Plan from a local street to a collector street.

Alderman Fitterer made a motion to approve Resolution 17-19. Motion seconded by Commissioner Benne. Motion passed 5/0.

Port Royal Road: This amendment is being processed by the Planning Department to amend the classification of Port Royal Road, in the Major Thoroughfare Plan, from a collector street to an arterial street between Duplex Road and Saturn Parkway.

Description and History: The Planning Commission requested that staff prepare a resolution to amend the Major Thoroughfare Plan, originally adopted in 2015 by the Board of Mayor and Aldermen. The City provided 30-day public notice in the newspaper. The Planning Commission approved Resolution 17-50 to change the classification of Port Royal Road as part of the consent agenda on June 12th, 2017:

1. **Resolution 17-50:** Submitted by the Planning Department to amend the classification of Port Royal Road, from Saturn Parkway to Duplex Road, from a collector to an arterial in the 2040 Major Thoroughfare Plan for the City of Spring Hill.

Alderman Fitterer made a motion to approve the Consent Agenda with staff conditions. Motion seconded by Commissioner Koss. Motion passed 7/0.

Summary: At the request of the Board of Mayor and Aldermen staff has prepared both amendments for joint consideration and vote. Staff supports these amendments to the City's Major Thoroughfare Plan.




