

**ORDINANCE 19-04**

**AN ORDINANCE OF THE CITY OF SPRING HILL, TENNESSEE, ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES**

**WHEREAS**, the City of Spring Hill Board of Mayor and Aldermen adopted an updated Municipal Code completed by American Legal Publishing Corporation on September 18, 2017; and

**WHEREAS**, American Legal Publishing Corporation has completed the first supplement, 2018 S-1 Supplement to the Code of Ordinances of the City of Spring Hill, Tennessee, which supplement contains all Ordinances of a general and permanent nature enacted since the prior codification; and


**WHEREAS**, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect upon approval.



**PURPOSE:**

The Spring Hill Municipal Code must be updated to include ordinances passed after previous codification. If approved, this will update the Spring Hill Municipal Code through Ordinance 18-25. (It includes the UDC and the most current version of the Rules of the Road.)

**BACKGROUND:**

The Board of Mayor and Aldermen approved a Municipal Code update by American Legal Publishing LLC in September 2017, with the option of periodical updates.

**FINANCIAL IMPACT:**

The cost for the update is under \$1,000.00 and is covered in the current budget.

**STAFF RECOMMENDATION:**

Staff recommends approval of 2018 S-1 Supplement to the Code of Ordinances as authorized by adoption of Ordinance 19-04.
