

ORDINANCE 20-08

AN ORDINANCE OF THE CITY OF SPRING HILL, TENNESSEE, ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES

WHEREAS, the City of Spring Hill Board of Mayor and Aldermen adopted an updated Municipal Code completed by American Legal Publishing Corporation on September 18, 2017 and approved the first supplement 2018 S-1; and

WHEREAS, American Legal Publishing Corporation has completed the second supplement, 2019 S-2 Supplement to the Code of Ordinances of the City of Spring Hill, Tennessee, which supplement contains all Ordinances of a general and permanent nature enacted since the prior codification; and


WHEREAS, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect upon approval.

NOW, THEREFORE, BE IT BE ORDAINED BY THE CITY OF SPRING HILL, TENNESSEE, BOARD OF MAYOR AND ALDERMEN:

Section 1. That 2019 S-2 Supplement to the Code of Ordinances of the City of Spring Hill, Tennessee as submitted by American Legal Publishing Corporation, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.





PURPOSE:

The Spring Hill Municipal Code must be updated to include ordinances passed after previous codification. If approved, this will update the Spring Hill Municipal Code through Ordinance 19-36.

BACKGROUND:

The Board of Mayor and Aldermen approved a Municipal Code update by American Legal Publishing LLC in September 2017, with the option of periodical updates. The first update was 2018 S-1, adopted in February 2019.

FINANCIAL IMPACT:

The cost for the update is \$1,952.00 and is covered in the current budget.

STAFF RECOMMENDATION:

Staff recommends approval of 2019 S-2 Supplement to the Code of Ordinances as authorized by adoption of Ordinance 20-08.
