**A RESOLUTION TO AUTHORIZE THE  
DISPOSAL OF POLICE REMINGTON SHOTGUNS**

**WHEREAS**, the Spring Hill Police Department currently has thirty-nine (39) Police issued Remington shotguns and two (2) .22 Caliber rifles in its inventory; and

**WHEREAS**, the Spring Hill Police Department intends to replace the shotguns and rifles with less lethal weapons and to upgrade our firearms inventory; and

**WHEREAS**, the Police Department request to dispose of the Remington Shotguns and rifles by selling them to Kings Firearms and More, LLC, a federal license firearm dealer; and


**WHEREAS**, Spring Hill Police Department will receive a trade-in-allowance, \$12,635.00, of the purchase price, towards the acquisition of less lethal weapons and to upgrade firearms inventory; and

**NOW, THEREFORE BE IT RESOLVED**, that the City of Spring Hill Board of Mayor and Alderman authorizes the sale of Remington Police Shotguns and rifles to King's Firearms and More, LLC, and to receive a trade-in allowance of \$12,635.00 for the acquisition of less lethal weapons and the upgrade of firearms inventory.

**BACKGROUND:**

The Police Department currently has (39) police issued Remington shotguns in its inventory and ( 2) .22 caliber rifles. The shotguns were previously issued to officers in years past as a weapon to be carried in the vehicle, and deployed for officer safety if the situation warranted it.

The Police Department has since issued departmental Police rifles to its officers, due to the change in society. The police rifle is better suited for officers in today's environment by providing better protection for the officers.

The department is requesting to dispose of these weapons, by selling them to Kings Firearms and More, LLC, federal licensed firearms dealer. The Police department will receive a trade-in-allowance of the sell price from Kings Firearms. The Department will then apply the allowance towards the acquisition of less lethal weapons for the officers.

The less lethal weapon will be a 40 mm launcher that if used, will discharge a bean bag round. Less lethal weapons will allow the officers, if the situation allows when confronted with a hostile situation, to use this round of ammunition instead of firing an issued rifle or handgun. The result is to prevent serious bodily injury or death to a person. By utilizing a less lethal weapon, bean bag, it minimizes the injury to a person, with the goal of ending the situation without having to use deadly force.

Sale price of Remington Shotguns, \$12,635.00

Kings Firearms was the only federal license dealer to submit a quote. Several other dealers were contacted but did not submit.
